

TDM Interconnection Kills STIR/SHAKEN

- My wild guestimate is that 35% of all calls in the US will not be able to be validated. We just don't have any good data here.
- There may be perverse incentives to drop calls from SIP UA's to TDM.
- All IP at Interconnection can work for TDM centric networks.
- TDM> Media/Signaling GW > SBC SBC > Media/Signaling GW > TDM
