2019 AGM Voting Issues

Issue 1: Voting For New Directors

- Maximum of 11 Directors in total, and 4 total Participant Member Directors (not affiliated with a Full Member company) allowed on board per current bylaws.
- Since the seat occupied by one participant member (Richard Shockey) is up for election, and the seats held by Mary Barnes, Martin Dolly and Philip Linse are Participant board member seats, one Participant (Individual) Member can be elected in this election (or re-elected in the case of Richard Shockey).
- > Issue 2: Discharge of Director Liability

Running of Election, Tabulation of Votes

- Final Request for Ballots to be Cast
- Official Voting Deadline Reached
- A Motion to Dispense with the Electronic Calculation of Votes as specified in SIP Forum Bylaws as the election is uncontested (i.e., 6 candidates for 6 available/open seats; and all candidates have received votes from > 50% of eligible voting Full Member companies)
- Perform Manual Count of Voting Issue #2

2019 SIP Forum Milestones

- SHAKEN is being deployed by mandate by the CRTC in Canada
- Held Most Attended and Financially Successful SIPNOC to Date (SIPNOC 2019)
