Session Initiation Protocol Forum (SIP Forum LLC), hereinafter referred to as the Association, is a US-based non-profit industry association formed as a focal point for Organizations and individuals involved in IP communications and SIP-based communications markets to promote the commercial value and benefits of the technology.

The goal of the Association is to spread information about the general value and usefulness of SIP-based IP communications technologies and the services that could be created on top of a SIP-based infrastructure. The Association shall have a general business approach where experiences can be discussed and used to provide input to standardization bodies. SIP Forum shall not produce standards where another body is better suited to produce the standard. SIP Forum shall not prescribe certain technology solutions. The goal of the Association will be achieved by developing case studies, producing technical documents or software, posting and generating white papers and by sharing information between service providers, product manufacturers and academic and research institutions.

The Association has three classes of Members: **Full Members**, which may vote in elections for the Board of Directors of the Association, and **Academic/Institutional** and **Participant** (Individual) Members, who shall be non-voting Members. Full Members pay an annual membership fee (currently \$12,500 USD). Participant Members must be individuals, and Participant and Academic/Institutional membership is free.

Full Members shall be legal entities that are vendors or users of SIP-based products or services, and which in addition have demonstrated substantial leadership in and a good faith commitment to the purposes and objectives of the Association set forth from time to time by the Board of Directors.

Your Membership Application is subject to the terms stated in this Application Form and the applicable provisions of the Bylaws of the Association as currently available on the website of the Association. By submitting this Application, you agree to these terms. Please note that breach of any of the obligations contained in this Application Form or the bylaws of the Association, as from time to time revised, including failure to pay any membership or subscription fees in a timely manner, may result in suspension or termination of membership rights in accordance with the bylaws of the Association. The Membership subscription of the Applicant becomes effective after payment of the applicable annual membership fee and acknowledgement of receipt of this Application by the management of the Association.
